PART I

MODIFICATION OF DEFINITIVE MAP

Description of path to be deleted

That length of Footpath CB488 which commences at its junction with Ashford Road and runs southwestwards for 186 metres (A-B), southerly for 160 metres (B-C), thence southeasterly through southerly running between the buildings for 100 metres (C-D) to its junction with Footpath CB464.

Description of path to be added

A new length of Footpath with a width of 2 metres which commences at the same point A (previously described) and runs south southeasterly for 42 metres (A-X), southeasterly for 70 metres (X-Y) thence southerly 210 metres (Y-Z) where the new route meets its new junction with Footpath CB464 which lies 162 metres north-east of the original junction.

MODIFICATION OF DEFINITIVE STATEMENT

The entry for CB488 is amended by the addition of the following: -

Diverted by Kent County Council (Footpath CB488 (part) Thanington Without) Public Path Diversion Order 2002 with a prescribed width of 2 metres for the new length of path. The new length of path is renumbered CB541.
